Mr. Bucknavage – We are good I was just here about the parking and we have covered that.

Mr. Granteed – Enterprise Street – I have a few items I would like to talk about. Corner of N. Main and Powell Street there is a head board and foot board sitting there for the last 3 months.

Yozwiak - Mr. Sax will contact the DPW and get that picked up.

Mr. Granteed – Snow plowing, I appreciate the snow plowing on my road, but there comes a point when you are just over doing it. And its only damaging the roads. There has to be common sense used when plowing.

Yozwiak – We will talk to the guys.

Mr. Granteed - If its an inch of snow they don't need to plow.

Yozwiak - They drop it hard, Mr. Sax will talk to them.

Mr. Granteed – The next issue is South Main Street, where the high school is. There are no sidewalks and the kids walk along that road and its dark and dangerous, someone is going to end up hurt. These kids don't look where they are going

Yozwiak – We have a meeting with the School Director, this would be their responsibility. And we have talked with them before but we will bring it up again.

Mr. Granteed - I am also curious about the traffic lights on Abbott and South Main.

It seems like expensive hardware are they going to get used?

Attorney Menn - That's all PennDOT.

Mr. Granteed – The last thing is the rain tax. I was under the impression that the rain tax was going to be something that was shared, and now I feel like a fool. You guys need to do something about this. The people around us are not paying, and we shouldn't be either. If they cant go about it the right way then we shouldn't be on the hook for it. Yozwiak – If I could just comment on that – 2 of us voted against it but to be honest with you Joe, we get reimbursed for repairs we make from that money. I don't know if you noticed but there was a large pipe on River Street that burst and we had to replace. That was 180,000 project we used our reimbursement for that project. Its not a lot and it's a fair tax. We get street cleaning, and this reimbursements for catch basins and repairs. Granteed – That's all well and good, you think its not expensive but for some people it is. They have to sacrifice to pay it. You get reimbursed but what do I get out of it?

Yozwiak – You see it through storm drains being cleaned out and repaired to keep water out and there is no flooding. It's a benefit,

Mr. Granteed - But the responsibility should be evenly doled out - these other communities should be paying.

Yozwiak - We try to be fair. And it is a good program,

Granteed – I don't think it is fair, I shouldn't have to pay when these other communities don't. Back Mountain doesn't pay, Lackawanna county doesn't pay. Its not the way the plan was.

Yozwiak - We will take it into consideration.
